ORDER OF RECOGNITION

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, **Kamad Giri Shiksha Avam Samajik Sansthan's D.EL.Ed. College, Survey Nos. 132 to 136, Piproli Road, PO-ITM Gwalior, Village-Kedarpur, Tehsil & District Gwalior-474011 M.P. (Code No. WRCAPP312)** had applied on 28-10-2009 to the Western Regional Committee of the NCTE for grant of recognition for starting the D.EL.Ed. Course with an annual intake of 50.

2. AND, WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith and the documents subsequently received till 13-04-2010, the WRC constituted the visiting team in its 134th meeting held on May 5-6, 2010 which inspected the institution on 25-05-2010. The WRC considered the visiting team report, documents and videograph in its 136th meeting held on June 5-7, 2010. The State Govt. did not send its recommendations in response to the letter of WRC dated 10-02-2010 and reminder dated 13-04-2010. The WRC issued the show cause notice dated 19-06-2010 under the proviso to section 14(3)(b) of the NCTE Act for the following deficiencies :-

- * The college building was under construction as visible in the video recording.

3. AND, WHEREAS the institution submitted its written representation dated 7-7-2010 which was considered by WRC in its 138th meeting held on July 20-21, 2010. The WRC issued the letter of intent prior to recognition dated 28-7-2010 under Clause 7(9) of the NCTE (Recognition, Norms & Procedure) Regulations, 2009. In response to the letter of intent, the institution submitted its reply dated 30-08-2010 which was received by WRC on 3-9-2010. The WRC considered the reply in its 140th meeting held on September 14-15, 2010 and asked the institution by letter dated 1-10-2010 to clarify the following :-

- * Attested copies of mark-sheets and experience certificate of Principal and lecturers be submitted.

4. AND, WHEREAS the institution approached the Hon'ble High Court at Gwalior in WP 5885 of 2010, seeking a direction to WRC to issue the order of recognition pursuant to the letter of intent already issued by it and the Hon'ble High Court was pleased to direct the WRC to take the decision in its next meeting. In compliance of court order, the WRC considered the application in its 142nd meeting held on November 22-24, 2010 and decided to reject the application for non-submission of attested copies of mark-sheets and experience certificate of the Principal and lecturers in response to its previous letter dated 1-10-2010. The order of refusal dated 4-1-2011 was issued.

5. AND, WHEREAS the institution again approached the Hon'ble High Court at Gwalior in WP 290 of 2011, challenging the order of refusal dated 4-1-2011 on the ground that it had not received the letter for clarification of WRC dated 1-10-2010. It was further submitted that the attested copies of mark-sheets and experience certificate of the Principal and lecturers were already sent to the WRC. The WRC had received such attested copies on 16-12-2010 i.e. after decision of refusal by WRC. The Hon'ble High Court was pleased to quash the order of WRC dated 4-1-2011 and directed it to pass the fresh order after considering the entire documents on record of the case by a speaking order and in accordance with law within two months from the date of receipt of certified copy of the court order. In compliance of court order, received on 23-5-2011, the WRC considered the entire documents on record of the case including the attested copies of mark-sheets and experience certificate of the Principal and lecturers in its 151st meeting held on June 27-29, 2011 and, being satisfied that the qualified faculty was appointed by the institution which was in position, decided to grant the recognition under Clause 7(1) of the NCTE (Recognition, Norms & Procedure) Regulations, 2009.

6. NOW, THEREFORE, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to Kamad Giri Shiksha Avam Samajik Sansthan's D.E.L.Ed. College, Survey Nos. 132 to 136, Piproli Road, PO-ITM Gwalior, Village-Kedarpur, Tehsil & District Gwalior-474011 M.P. (Code No. WRCAPP312) for starting the D.E.L.Ed. Course of Primary level of 2 years duration with an annual intake of 50 from academic session 2011-2012.

7. Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations 2009.

8. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.


9. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009.

10. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.

12. If, at any time, either on sue-moto inspection or on any representation received from any person, the WRC-NCTE is satisfied that the institution has contravened any of the provisions of the NCTE Act, or the rules, regulations, orders made or issued there under or any condition subject to which the recognition/permission was granted, the recognition/permission may be withdrawn under the provisions of Section 17 (1) of the NCTE Act.


